

**RELEASE AND WAIVER OF LIABILITY,
ASSUMPTION OF RISK AND INDEMNITY AGREEMENT**

COSTAS CONSULTING LTD. O/A THUNDERBIRD OUTFITTERS HUNTING EXCURSION (the "EVENT")

WHICH EVENT PERIOD COMMENCES _____ AND ENDS _____.

IN CONSIDERATION of being permitted to participate, attend, observe, partake in, in any way in the EVENT organized by COSTAS CONSULTING LTD. O/A THUNDERBIRD OUTFITTERS (the "Corporation") or its staff, THE UNDERSIGNED, for himself, herself, his or her personal representatives, heirs, and next of kin (the "Participant"):

1. Acknowledges, agrees, and represents that he or she have or will immediately upon participating in the EVENT and will continuously thereafter, inspect the areas and surroundings which he or she enters, and he or she further agrees and warrants that, if at any time, he or she feels anything, any area, or any portion of the EVENT or an excursion to be unsafe, he or she will immediately advise the COSTAS CONSULTING LTD. O/A THUNDERBIRD OUTFITTERS Employee in charge of the EVENT of such and if necessary will leave or cease to participate in the EVENT immediately and he or she assumes the sole responsibility to determine if any area or portion of the EVENT is unsafe and/or dangerous and cease to participate.
2. HEREBY RELEASES, WAIVES, DISCHARGES AND COVENANTS NOT TO SUE, the Corporation, its employees, volunteers, personnel, other EVENT participants, or any other person that gives advice about or related to the EVENT (hereinafter collectively referred to as the "**Releasees**") FROM ALL LIABILITY TO THE UNDERSIGNED, and their personal representatives, assigns, heirs, and next of kin, FOR ANY AND ALL LOSS OR DAMAGE, AND ANY CLAIM OR DEMANDS THEREFOR ON ACCOUNT OF INJURY TO THE PERSON OR PROPERTY OR RESULTING IN DEATH OF THE UNDERSIGNED ARISING OUT OF OR RELATED TO THE EVENT, WHETHER CAUSED BY THE NEGLIGENCE OF THE RELEASEES OR OTHERWISE.
3. HEREBY AGREES TO INDEMNIFY AND SAVE AND HOLD HARMLESS the Releasees and each of them FROM ANY LOSS, LIABILITY, DAMAGE, OR COST they may incur arising out of or related to the EVENT, WHETHER CAUSED BY THE NEGLIGENCE OF THE RELEASEES OR OTHERWISE.
4. HEREBY ASSUMES FULL RESPONSIBILITY FOR ANY RISK OF BODILY INJURY, DEATH OR PROPERTY DAMAGE arising out of or related to the EVENT whether caused by the NEGLIGENCE OF RELEASEES or otherwise.
5. HEREBY acknowledges that THE ACTIVITIES OF THE EVENT MAY BE VERY DANGEROUS and involve the risk of serious injury and/or death and/or property damage. Each of THE UNDERSIGNED, also expressly acknowledges that it is their PERSONAL CHOICE WHETHER OR NOT TO WEAR A HELMET, and ASSUMES FULL RESPONSIBILITY FOR ANY RISK OF BODILY INJURY OR DEATH arising out of or related to the EVENT. Each of THE UNDERSIGNED, also expressly acknowledges that INJURIES RECEIVED MAY BE COMPOUNDED OR INCREASED BY NEGLIGENT RESCUE OPERATIONS OR PROCEDURES OF THE RELEASEES.
6. HEREBY ASSUMES FULL RESPONSIBILITY FOR ANY RISK OF BODILY INJURY, DEATH OR PROPERTY DAMAGE occurring while riding on any of their personal vehicles, or any vehicle of any of the Releasees.
7. HEREBY agrees that this Release and Waiver of Liability, Assumption of Risk and Indemnity Agreement extends to all acts of negligence by the Releasees, INCLUDING NEGLIGENT RESCUE OPERATIONS and is intended to be as broad and inclusive as is permitted by the laws of the Province of Saskatchewan and that if any portion thereof is held invalid, it is agreed that the balance shall, notwithstanding, continue in full legal force and effect.

I HAVE READ THIS RELEASE AND WAIVER OF LIABILITY, ASSUMPTION OF RISK AND INDEMNITY AGREEMENT, FULLY UNDERSTAND ITS TERMS, UNDERSTAND THAT I HAVE GIVEN UP SUBSTANTIAL RIGHTS BY SIGNING IT, AND HAVE SIGNED IT FREELY AND VOLUNTARILY WITHOUT ANY INDUCEMENT, ASSURANCE OR GUARANTEE BEING MADE TO ME AND INTEND MY SIGNATURE TO BE A COMPLETE AND UNCONDITIONAL RELEASE OF ALL LIABILITY TO THE GREATEST EXTENT ALLOWED BY LAW.
